All students whose application for conversion to dual degree programme has been approved, will be treated as M.Tech students for the purpose of fee calculation. If the application for conversion is in process, they will be considered at par with BT/BS students.

(1) Students belonging to SC/ST/PH categories are given 100% waiver on the Tuition Fee.

(2) Tuition fee for modular course will half that for regular course

(3) SC/ST student is not charged the hostel seat rent if parent's/guardian's income is less than ₹6 Lakhs.

* For 2016 Batch BT/BS students:


MEB - The most economically backward B. Tech./BS students (whose family income is less than ₹1 lakh per annum) will get full remission of the tuition fee.

OEB - Other economically backward B. Tech./BS students (whose family income is between ₹1 lakh to ₹5 lakhs per annum) will get remission of 2/3rd of the tuition fee.

C. MESS DUES AS PER ACTUAL (To be paid to the Hall of Residence)

In addition to above it was also decided that during summer 2016-17, the mess establishment charge, water charge and hostel seat rent shall be charged from the UG students registering for mess only.
