OFFICE ORDER

Subject: Grant of revised rate of Daily Allowance on Tour.

Ref : No. Estt./6CPC/OO/2011-IITK/228 dated May 10, 2011.

The Ministry of Personnel, Public Grievances and Pension (DoPT), Government of India has clarified vide Office Memorandum No. A-27012/1/2014-Estt.(Allowance) dated 28.04.2014 for the revision of rates of various allowances mentioning their new limits.

Further, the Competent Authority has also approved the enhancement of rates in accordance with the above notification of the Ministry Ministry of Personnel, Public Grievances and Pension (DoPT), Government of India that the rates of above allowances shall automatically increase by 25% of the base rate every time, the dearness allowance payable on the revised pay structure goes up by 50%.
