- 3. The quantity mentioned in this enquiry is and shall be deemed to be only aproximate and will not in any manner be binding on the Institute.
- 4. Firms will quote seperately for each article.
- The Rate offered should be free delivery of IIT kanpur or ex-godown in case of firms situated outside kanpur. If items is imported then the firms should quote the price on F.D.B basis.
- 6. In case of Ex-godown terms the amount of packaging, forwarding freight etc. should clearly be mentioned by percentage or lump sum amount. Current rate of sales tax must be mentioned.
- 7. The rates offered should be exclusive or inclusive sales tax. The rates applicable should clearly be specified .
