- 1. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. Bidders are bound to accept the orders accordingly.

1. General Terms and Conditions-

- 1.10 Financial Certificate:

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
