Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consen t).

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the q uantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the con tract at the contracted rates. Bidders are bound to accept the orders accordingl y.

7. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with G STIN of Consignee only.

Upload Manufacturer authorization: Wherever Authorised Distributors are s ubmitting the bid, Manufacturers Authorisation Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.

9. Service & Support

Dedicated /toll Free Telephone No. for Service Support: BIDDER/OEM must have Dedicated/toll Free Telephone No. for Service Support.

10. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provide r must be located in the state of Consignee. DOCUMENTARY EVIDENCE TO BE S UBMITTED.

11. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telephone Numbers for Service Support.

12. Certificates

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 ce rtification.

13. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

14. Certificates

15. Warranty

Warranty period of the supplied products shall be as given in specifications from the date of final acceptance of goods or after completion of installation, commis sioning & testing of goods (if included in the scope of supply), at consignee loca tion. OEM Warranty certificates must be submitted by Successful Bidder at the t ime of delivery of Goods. The seller should guarantee the rectification of goods i n case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Mainten ance Service group in INDIA for attending the after sales service. Details of Serv ice Centres near consignee destinations are to be uploaded along with the bid.

16. Past Project Experience
