## **OFFICE ORDER**

# Sub: Appointment of Courier Agencies and restructuring of the Central Dak Dispatch System.

Central Dak Dispatch System in the General Cell of Administration Section has been operative since long mostly for dispatching the Dak sent by various Departments/Sections/Units of this Institute. However, it has been observed that of late many Departments/Sections/Units are dispatching their respective mails/documents through different courier agencies for speedy dispatch and are subsequently submitting the bills for the same in the Accounts Section. This has been causing extra cost to Institute and additional work in Accounts Section to settle the above said bills.

To streamline and standardize the Central Dak Dispatch and Distribution System, it has been decided to **outsource the Central Dak Dispatch System**. The total activity is accordingly sub-divided into two categories:-

- (a) External dak delivery within India, and abroad
- (b) Collection and delivery of internal dak

To this effect, the tenders from leading courier agencies were invited. The duly constituted committee in this regard, after scrutiny, finally identified and selected two courier agencies. These are as under:-

- i. M/s. Blaze Flash Couriers Pvt. Ltd., (Area Office, 7, Shyam Sunder Building,24/18-B, The Mall Kanpur)
- ii. M/s. First Flight Couriers Ltd., (Area Sales Manager, 4<sup>th</sup> Floor, Commerce Centre, Chunnigunj, Kanpur)

M/s. Blaze Flash Courier agency is assigned the task of:

(a) Collection and delivery of internal dak and also distribution of the internal dak of

all Departments/Sections/Units within the premises of the Institute

(b) External dak delivery within India and abroad.

In addition, M/s. First Flight Courier agency has been assigned the task for only booking of the dak for external deliveries within India and abroad.

The Departments/Sections/Units may choose either of the above agencies to send the external dak or in the alternative even through the Post Office by purchasing the stamps from their own imprest fund.

The Departments/Sections/ Units desirous of sending the external dak through courier agencies are to mark the name of the courier agency on the top of the envelope and arrange to hand it over to the identified courier agency located at Room No.101 (C) in the Faculty Building, or call the representative of the courier agency (Phone No. 6123 for First Flight and 6122 for Blaze Flash) to their respective Departments/Sections/Units for collection of the Dak. In case of confidential mail, the Departments/Sections/Units may send it through their own staff. Consequent to above, the franking machine kept in the Administration Section will be transferred to GATE/JEE Office for their utilization.

The destination wise rate list within India, and abroad, in respect of above said courier agencies is annexed as Annexure - A.

The following points may please be noted and adhered to by the Departments/ Units/Sections while dispatching the mails through the above authorized couriers agencies:

- 1. For convenient tracking, the legible and complete address with telephone/mobile No. be mentioned on the envelope earmarked for dispatch.
- 2. Receipt of each dispatch of mail is to be obtained from the authorized agencies in order to tally with the proof of delivery (POD).

- 3. These authorized courier agencies are having services limited only to metro cities, district head quarters and urban cities/ area, hence no mails to remote areas be sent through these authorized courier agencies. The availability of service may please be enquired before handing over the Dak to the agency.
- 4. The bill of each calendar month is to be checked and forwarded by the respective Departments/ Units/Sections to the Account Section after verifying with the proof of delivery.
- Temporary accommodation to these authorized agencies has been given in Room No.101 B (adjacent to the Estate Office) with phone Nos.6122, 6123 respectively. In case of any query, the same may be clarified from office mentioned above on phone, or in person.
- All Departments/Units/Sections have freedom to choose to send their mail by any of the authorized courier agencies, or even by Post Office, after checking cost & services.

M/s. Blaze Flash Couriers Pvt. Ltd. has been authorized for internal distribution of the Mails/documents of the Institute which will come into force w.e.f. July 1<sup>st</sup>, 2006. A separate office order will issued for the purpose soon.
