XXIII Inter IIT Staff Sports Meet, IIT Kanpur (Dec. 21-25, 2016)

CONDUCT/PROTEST

For all games and sports, the decision of the referees and the umpires will be final and binding and no protest shall be entertained. Therefore, any team leaving the field of play as a mark of protest and conceding a walk-over shall be deemed to have lost the fixture and will be eliminated from the event. Only the remaining teams will be considered as participating teams in that event.

Protest against the decision of an umpire/referee on a point of rule and any other protest in connection with the concerned event, shall be writing along with a protest fee of Rs. 500.00 addressed to the Jury of Appeal, Organizing Institute and must reach the Organizing Secretary or any member of the Board of the Host Institute within an hour of the conclusion of the concerned game duly signed by the Officials with name & designation of that particular IIT. In case of events being conducted outside, the protest in writing shall be handed over to the Jury of Appeal within an hour of arrival.

A team/competitor shall be permitted a grace of 15 minutes from the announced timing of the event and then a walk-over shall be awarded, unless genuine reasons beyond his/her control are presented and accepted by the Board.

DISRUPTION/POSTPONMENT

Any event abandoned or disrupted due to unavoidable reasons shall be postponed or continued as the case may be and as per rules specified in the current rules of the respective Federation/Association. In case where the Federation Association rules cannot be implemented, the decision will be left to the Board whose ruling shall be final.

GENERAL RULES

- (a) The total contingent strength from each IIT is 72 (including 02 officials: 60 men + 12 women). The transfer of seats from men to women and vice-versa will not be permitted.
- (b) The information regarding the sports equipment which will be used in sports meet must be sent to officials of all IITs by the end of October.
- (c) The order of events shall be fixed and notified well in advance to all participating IITs.
- (d) Sports Association of the host IIT will be providing the latest federation rule book of all the games at the Control Room so that any member can refer to the rules.
- (e) It will be the responsibility of the Board to provide the latest changes in the rules and regulations during the pre-meet board meeting.
- (f) All the participants will bring their ID cards and photograph. The host IIT may issue participant cards only to the players as mentioned at 12(a) from a particular IIT to participate. The host IIT will also provide list of participants of all IITs to the officials of all IITs.
- (g) It is compulsory for all contingent members to be present during the March-past. Noncompliance of the same will lead to disciplinary action by the Sports Board and its decision will be binding on all contingent members.

1. ATHLETICS

- (a) The competition shall be conducted under the International Amateur Athletic Federation Rules as adopted from time to time by AAFI unless otherwise modified.
- (b) Except for relay races, each IIT will be entitled to enter not more than two competitors plus one reserve per event. For relay races, not more than one entry of four with one reserve per event shall be accepted.
- (c) As far as possible, changes, if any, should be intimated fifteen minutes before the start of the event. Lots for Lanes will be drawn as soon as the first call is given.
- (d) In a standard track of eight lanes, the first two from each of the three Heats and Best two losers will be chosen for the finals.
- (e) The competitions in the events shown in the Table-1 will be held. The corresponding points for athletics championship are also indicated in the table.
- (f) In case of tie for an individual event, points will be shared by both athletes and IITs as shown in Table-2. In case of relay events, the points will be double as the relay event has double weightage.
- (g) The sum total of points secured in all events in athletics by an IIT will determine first, second, third positions in athletics.
- (h) If an athlete after qualifying in does not participate in the finals, he may be debarred from the competition and will not be considered for best athlete, until or unless he has a valid reason as per AAFI rules.
- (i) Best Athlete will be decided by the maximum' number of points obtained by an athlete in the Athletic Championship.
- (j) Certificates shall be awarded for the first three places in all the athletic events.

2. BADMINTON/LAWN TENNIS/TABLE TENNIS

- (a) The competition shall be conducted under the International Federation rules as adopted from time to time by the respective Associations of India, unless otherwise modified.
- (b) The tournament will be conducted on the lines of Inter-state Badminton/Tennis/Table Tennis Championships.
- (c) The tie shall be decided by the combined result of 2 singles and 1 double. The result of a tie, however, can be declared when either of the competing teams wins 2 matches.
- (d) Each match shall be decided by the result of best of three games, except TT which will be decided on best of five games.
- (e) The order of events shall be First Single/Doubles/Second Single.
- (f) Tie in the league matches will be resolved successively by applying the following criteria:
 - I. Tie will be resolved by considering the results of the second single match.
 - II. Ratio of (Individual matches won/Individual matches lost).
 - III. Ratio of (Games won by the team/Games lost by the team)
 - IV. Ratio of (Points for/Points against).

3. BASKETBALL

- (a) The tournament will be conducted according to the International Basketball Federation Rules as adopted from time to time by the Indian Basketball Federation unless otherwise modified.
- (b) During matches, if the score is same after the end of the scheduled Time, Basketball Federation Rules will be applied, i.e., the game shall continue with as many extra periods of 5 minutes each as is necessary to break the tie.
- (c) Tie in the league matches will be resolved by successively applying the following criteria:
 - I. If two teams are tied head to head, the team which has won the match in the league will be placed above the other team.
 - II. If more than two teams are equal in placing, the tie will be resolved on the basis of the ratio of 'points for' to 'points against' considering the scores at the league matches between tied team alone.
 - III. If the teams are still tied after the second classification, the basket average will be used to determine the placing, taking into account only the results of the games between the teams that are tied.
 - IV. If there are still teams that are tied, the results of all their games will be used in the calculation of (ii) and (iii) above.

4. CRICKET (T20 Format will be followed)

- (a) Matches shall be played according to the ICC Rules in force, as adopted from time to time by the Board of Control for Cricket in India, unless otherwise modified.
- (b) All the matches shall be conducted on league-cum-knock out basis and each side is allowed to complete 20 over's unless the opposing team is dismissed earlier. Each bowler can bowl a maximum of 4 over's. The semi-finals and final will also be of 20 over's.
- (c) The bowling team is given 100 minutes to complete its quota of 20 over's. The penalty for every short over will be decided by all the IIT Captains prior to the meet.
- (d) The Cricket Captains should discuss the rules and regulations for the conduct of the cricket matches and should submit the report before the First Sports Board meeting. The Board meeting should discuss and approve the plan and it will be implemented.
- (e) After the league matches if all the teams of a pool having equal points then on the basis of the net run rate better team will be placed for the Semi Finals.
- (f) If there is a tie during the Semi Final matches (knock out) super over rules will be implemented.
- (g) If there is three pools, the best loser will be decided on the basis of the following rules for qualifying to the Semi Finals line up.
 - I. Whichever team scores maximum points
 - II. Net run rate will be applied
 - III. No. of wickets lost in all the matches played
 - IV. If still tie persist spin a coin will decide the best loser team.

**RULES REGARDING THE POSTPONEMENT OF CRICKET MATCHES
AFFECTED BY RAIN/FOG**

- a. When rain affects play during the innings of the first team itself, the match will be continued, from where it was stopped. The umpires shall decide whether the ground is fit for play or not.
- b. When rain affects the play during the innings of the Second Team and if the team batting second has not yet batted for at least half the number of over's, the match will be continued as in (a).
- c. If the team batting second has batted for more than half the total number of over's and if further play is not possible all the same, the winner will be the team with better scoring rate at that particular point where and when the second team stopped batting.

5. FOOTBALL

- (a) Matches shall be played according to the rules of the FIFA as adopted from time to time by the All India Football Federation unless otherwise modified.
- (b) The duration of each match shall be 60 minutes (30-10-30). During the league stage, after the expiry of play-time, if the tie still persists, the points shall be shared equally. In knock-out-stage, penalty kick rule will be followed.
- (c) If a player is shown 2 yellow or 1 red card irrespective of whether shown in league or knock-out stage, he will be debarred for the next match. It will be the duty of the table officials to inform the concerned captain about any card shown during the match.
- (d) In case of tie, goal differences, (i.e., Goals FOR minus Goals AGAINST) of all the matches played by the team shall be considered. If tie still persists, number of goals 'AGAINST' throughout the tournament shall be considered.

6. VOLLEYBALL

- a) The rules of the International Volleyball Federation as adapted from time to time by the Volleyball Association of India (VFI) shall be followed unless otherwise modified.
- b) The tournament shall be played on league cum knockout basis. All the matches shall be played on the basis of 3 sets.
- c) Any team refusing to play a match without justification will be eliminated from the competition and the results of the matches already played will be cancelled. In case of teams having equal points, following rules will determine the ranking. The calculation will be first based on the match between the tied teams and then based on over all league matches.
 - I. Ratio of (Total number of game Won/Total number of games Lost)
 - II. Ratio of (Total number of winning points/Total number of Lost Points).

7. DISCIPLINARY RULES

- a) A disciplinary committee will be constituted by the Sports Board consisting of at least one person from each IIT and the decision of this committee will be binding on all IITs.
- b) Each IIT will nominate one Sport Board Member for the disciplinary committee.

- (c) The responsibilities of this committee will be to look after and maintain discipline during Inter NT Staff Sports Meet. In case of any unruly dissent or gesture against the conducting officials, the concerned IIT shall be warned by the board. In case of further violation, the particular team of the concerned IIT shall be debarred from the Inter IIT Meet.
- (d) Unruly behavior of the staff members of any IIT contingent shall be generally dealt with, punishment/debarring etc.
- (e) No members, including the Board members, shall be allowed inside the track during the meet.
- (f) Possession of liquor, carrying of intoxicating drinks & consumption of liquor in hostels, Guesthouse, parks, playground & roads of the institute is completely banned. If any of the Contingent/board members found drunken in the campus, then they would be expelled from the campus with an immediate effect. In addition, concerned player will be debarred for three to five years for a player and two years for a team in taking part in Inter IIT sports meet. The sports board recommend to the concerned IIT Director to take disciplinary action against the player.

8. SPECIAL CLAUSE

Any point not directly covered by these rules, shall be decided in the light of the rules most nearly applicable and in accordance with the general tenor and the spirit of the said rules.
