<ul style="list-style-type: none"> <li>• A male student who was subjected to sexual assault by a non-resident of IIT Kanpur, complained against his fellow student for being complicit in this incident and supporting it.</li> </ul>
<ul style="list-style-type: none"> <li>• A student complained of indecent remarks made by a team mate.</li> </ul>
<ul style="list-style-type: none"> <li>• A student complained of inappropriate touch by a fellow student.</li> </ul>
<ul style="list-style-type: none"> <li>• A female student complained of academic misconduct and being verbally abused in public and stalked by a fellow student.</li> </ul>

<ul style="list-style-type: none"> <li>• A visitor to institute complained that one of the shopkeepers from a shop on IIT Kanpur campus had asked her inappropriate questions and touched her body without her consent.</li> </ul>

<ul style="list-style-type: none"> <li>• An audio clip with sexual innuendo was played during the tutorial for a course when a female tutor was teaching.</li> </ul>
