#### 2. Generic

Bidders shall quote only those products in the bid which are not obsolete in the market and has at least 2 years residual market life i.e. the offered product shall not be declared end-o f-life by the OEM before this period.

#### 3. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not tak e any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 4. Generic

**End User Certificate:** Wherever Bidders are insisting for End User Certificate from the Bu yer, same shall be provided in Buyer's standard format only.

#### 5. Generic

Duration of the service contract may be extended up to 6 months beyond the initial contract duration (subject to satisfactory performance and mutual consent).

#### 6. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to a ccept the orders accordingly.

#### 7. Generic

Supplier shall ensure that the Invoice is raised in the name of Consignee with GSTIN of Consignee only.

#### 8. Generic

**Upload Manufacturer authorization:** Wherever Authorised Distributors are submitting t he bid, Manufacturers Authorisation Form (MAF)/Certificate with OEM details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid.

## 10. Service & Support

AVAILABILITY OF OFFICE OF SERVICE PROVIDER: An office of the Service Provider must be I ocated in the state of Consignee. DOCUMENTARY EVIDENCE TO BE SUBMITTED.

#### 11. Service & Support

Escalation Matrix For Service Support : Bidder/OEM must provide Escalation Matrix of Telep hone Numbers for Service Support.

#### 12. Certificates

ISO 9001: The bidder or the OEM of the offered products must have ISO 9001 certification.

#### 13. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

The seller should guarantee the rectification of goods in case of any break down during the guarantee period
