10. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. 23. **Warranty**

. After award of contract, Successful Bidder can upload scanned copy of the DD in place of PBG and has to ensure delivery of hard copy to the original DD to the Buyer within 15 days of award of contract.

27. **Financial Criteria**

NET WORTH: Net Worth of the OEM should be positive as per the last audited financial statement.

28. **Buyer Added Bid Specific ATC**
