1. Those PG students who have a valid GATE score or have qualified in a recognized National level test, such as CSIR/UGC, NET, INSPIRE, NBHM etc. in addition to the tuition fee waiver, will be provided Institute Assistantship at the rates applicable to the Indian students, on the recommendation of the selection committee and approval of the Director.

2. Foreign students from CFTIs meeting the CPI requirement for Ph.d program will be considered equivalent to their Indian counterparts for the purpose of tuition fees and institute fellowship.

3. Fee for sponsored students:

ASEAN PhD Fellowship programme: As per sponsored/part time Indian PG students (refer to fee structure for Indian nationals)

Study in India: As per norms for self-sponsored foreign nationals.

AARDO: As per MoU.

ICCR/Any other sponsoring agency: As per sponsored foreign national PG students.

4. SAARC countries are: Afghanistan, Bangladesh, Bhutan, India, Maldives, Nepal, Pakistan and Sri Lanka

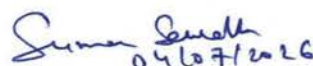
