### C. MESS DUES AS PER ACTUAL (To be paid to the Hall of Residence)

All students whose application for conversion to dual degree programme has been approved, will be treated as M.Tech students for the purpose of fee calculation. If the application for conversion is in process, they will be considered at par with BT/BS students.

(a) Students belonging to SC/ST/PH categories are given 100% waiver on the Tuition Fee.

(b) Tuition fee for modular course will half that for regular course

(c) SC/ST student is not charged the hostel seat rent if parent's/guardian's income is less than ₹6 lakhs.

# Day scholars are not charged water charges and mess establishment charges. However Hostel seat rent is to be paid.

### \* For 2016 to 2018 Batch BT/BS students:

MEB - The most economically backward B.Tech./BS students (whose family income is less than ₹1 lakh per annum) will get full remission of the tuition fee.

OEB - Other economically backward B.Tech./BS students (whose family income is between ₹1 lakh to ₹5 lakhs per annum) will get remission of 2/3rd of the tuition fee.

### IT IS MANDATORY FOR ALL STUDENTS WHO WILL STAY DURING THE SUMMER TO JOIN IN MESS.

In addition to above it was also decided in the HMC that during summer 2018-19, the mess establishment charge, water charge and hostel seat rent shall be charged from the UG students who will be staying back without registering for a course and they have to pay the mess charges for three (03) months. (No rebate will be applicable).
