However, If applicable, it is a condition that if the calculated value (after due calculation from the above formula) of the existing licensee, who already in possession of the said outlet, comes higher than the other bidder(s) calculated value, the existing licensee shall have the right for being awarded the outlet, provided that the existing licensee is willing to match the rates of the highest bid ranking and has technically qualified / shortlisted. If so, an undertaking to this effect shall have to submit by the bidder.	i. Financial bids of technically qualified / shortlisted bidders shall be opened. Appendix-C Finalisation for Award of the Tender: (Points 25 & 26, Pg. 10)	25. If existing licensee's calculated value comes highest, the tender will be allotted to the existing licensee. If this does not happen, however, the existing licensee is willing to match the amount quoted by the highest bidder, the tender will be awarded to the existing licensee. 26. If existing licensee is unable to match the quoted amount of the lowest bidder, the tender will be awarded to the bidder who quoted the highest amount.	i. The tender will be awarded to the bidder who quoted the Highest amount of per sq. mt. rate as per financial bid.
