1	Temperature Range	Ambient to 200°C or better
2	Temperature Resolution	0.01°C or better
4	Temperature Stability	±0.01°C or better at 100°C
5	Temperature Uniformity	±0.1°C per cm or better
6	Sample area	150 mm x 150mm or bigger
7	Cover for the hot plate	Needed
8	Maximum heating rate	75°C per minute or better at 100°C
9	Minimum heating and cooling rate	0.1°C per hour or better
10	Temperature profile	Programmable hot & cold plate is required to generate various temperature profile. Software should be compatible with Windows PC.
11	Documentary evidence	Vendors should include test certificate or documentary evidence for above specifications particularly for temperature resolution, temperature stability, temperature uniformity, minimum and maximum heating rate.
12	Warranty	1 year. Also, quote the price for second and third year warranty as an optional.

Terms and Conditions:

1. Evaluation will be done on the basis of technical specifications as per our tender notice.
2. Please do mention tender number clearly on envelop.
3. Only OEM or its authorised agents should quote.
4. Quotation should carry proper certifications like proprietary certificate, authorization certificate from manufacturer, etc.
5. Financial bids will be open only for those, who meets all technical specification.
6. After installation system's functionality should be demonstrated.
7. The supplier must have supplied & installed systems to institutions of national and/or international repute.
8. Quotation must indicate FCA / FOB or FOR prices.

9. The delivery period should be specifically stated. Earlier delivery may be preferred.
10. Payments terms: 70% against delivery at IIT Kanpur, 20% against installation and 10% against successful running of equipment for 3 months and approval.
11. Warranty/Guarantee should be clearly mentioned. The Warranty must start from the date of installation at IITK.
12. Validity of quotation should be at least for 60 days.
13. Maximum educational discounts should be applied.
14. The Penalty @1% per week or part thereof subject to max 10% will be deducted from the balance payment, if supply/integration is not completed within aforesaid delivery period.
15. Institute is exempted for partial custom duty (CD applicable to IIT Kanpur is 5.15%).
16. Concessional rate of GST (@ 5%) will be applicable with reference to Notification No. 45/2017 Central Tax (Rate) dated 14/11/2017. We will provide relevant certificate for this purpose. On import items for research purpose presently the GST applicable is 0% (Zero). DSIR certificate along with CDEC has to be submitted for availing concession. Vendor should use these GST rates in their quotation.
17. The indenter reserves the right to withhold placement of final order. The right to reject all or any of the quotations and to split up the requirements or relax any or all of the above conditions without assigning any reason is reserved.
18. At any time prior to the deadline for submission of bid, the Institute may, for any reason, at its own initiative, modify the bid document by amendments. Such amendments shall be uploaded on the website through corrigendum and shall form an integral part of bid document. The relevant clauses of the bid document shall be treated as amended accordingly. It shall be the sole responsibility of the prospective bidders to check the website from time to time for any amendment in the tender document. In case of failure to get the amendments, if any, the Institute shall not be responsible for it.
