Terms & Conditions:

- The crowd funding platform shall be based on open source technologies as far as possible and the source code shared with the institute without any royalty.
- 2. The alumni-networking platform/application has to be maintained for at least 2 years after the initial development period. The solution provider shall maintain regular reports, share all database/API, analytics reports and related documentation with the IITK project team.
- 3. The platform should also provide service for automated newsletters and bulk mails to IIT Kanpur alumni. Alumni office IIT Kanpur can use this feature for communicating with the alumni network from time to time. Also social media integration will be a standard feature of the platform.
- 4. The firms are requested to give detailed description and specification together with detailed drawings, printed leaflets and literature of the platform and technology.
- 5. Platform should support multiple projects with Multi-currency integration.
- 6. The vendor shall provide complete database schema and access to raw data, so that in the event IITK decides to change the platform in part or whole, the existing data can be easily updated and seamlessly ported to a new platform to allow for future maintenance and as 3.0 updates in case of any eventuality (since the alumni engagement is a long running process).

- Service provider should provide adequate training to the DoRA staff about the usage of the platform.
- The application solution provider firm/company should have experience in creating private or open platforms and should provide relevant links/proof for the same
- 9. Service provider should also provide copies of the work order/project report/proof for development of similar networks/application in the past.
- 10. The platform has to be developed and delivered within two months of signing the work order. The solution provider firm /company is also expected to offer upgrades from time to time during the AMC period. The cost of AMC shall be mentioned separately in the financial bid.
- 11. Payment Terms and Conditions:
 - · All prices are to be for IIT Kanpur.
 - 90% against Delivery and a 10% balance after successful installation and initial testing.
 - Maximum educational discount, if any should be offered.
 - Validity of quotation should be at least for 60 days after opening of the bid.
 - · Prices should include the installation and training cost.
 - Please note that L1 may not be the only criteria for deciding the outcome. In case there is an alternative pricing mechanism aviilable, please also share the same.
