- 1. Enquiry will be sent by UCP and IIT Kanpur will not be lible for any kind of postal irregularity/delay.
- 2. The quotation in duplicate should be enclosed in a properly sealed envelop addressed to the Asst. Registrar Store and purchase section. I. I.T., IIT Post office, Kanpur-208016. invariably giving on the envelop referance of enquiry and due date of opening.
- The quantity mentioned in this enquiry is and shall be deemed to be only approximate and will not in any manner be binding on the Institute.
- 4. Firms will quote seperately for each article.
- The Rate offered should be free delivery of IIT kanpur or ex-godown in case of firms situated outside kanpur. If items is imported then the firms should quote the price on F.D.B basis.
- In case of Ex-godown terms the amount of packaging, forwarding freight etc. should clearly be mentioned by percentage or lump sum amount. Current rate of sales tax must be mentioned.
- 7. The rates offered should be exclusive or inclusive sales tax. The rates applicable should clearly be specified .
- 8. The delivery period should be specifically stated. Ex-stock and earlier delivery may be prefered.
- 9. The firms are requested to give detailed description and specification together with detailed drawings and printed leaflets and literature of the articles quoted.
