AGREEMENT ON ACADEMIC EXCHANGE

Between

Indian Institute of Technology, Kanpur, India
And

University of Miyazaki, Japan

Indian Institute of Technology, Kanpur, India and University of Miyazaki, Japan, are signing this agreement in order to promote academic exchanges in education and research.

1. Under the existing law and other government rules and regulations of each country, both universities agree to develop academic exchanges in various areas of education and research on the basis of equality and reciprocity:
 - a) Exchange of researchers and other research staff
 - b) Conducting collaborative research projects and organizing symposia
 - c) Exchange of research data and materials
 - d) Exchange of students
 - e) Exchange of administrative staff
2. Specific details on the development and implementation of particular exchanges noted above shall be negotiated and agreed between both universities, and carried out in accordance with the memorandum.
3. Expenses to be incurred in the implementation of this agreement shall be the responsibility of each university, unless another agreement is agreed upon by both universities.
4. This agreement will remain in effect for five years from the date of signing, and is renewable thereafter for further five year terms subject to mutual consent. This agreement may be terminated by either university at any time by providing the other university with 6 months notice (in writing) of the intent to terminate.
5. In case of a dispute relating to any aspect of academic co-operation, both universities will jointly resolve the dispute in the spirit of independence, mutual respect, and shared responsibility.
6. This agreement will be written in English, and each university will keep one copy.
